### Preface

This “Guide for Applicants” provides information about the procedure for the submission of project proposals under the 4th EU-LAC Joint Call in STI 2022.

Part I provides overall information for applicants through “frequently asked questions” and answers.

In part II example screenshots of the actual online submission procedure via the online submission tool “pt-online” are presented, as well as step-by-step advice on how to realize the submission. However, the submission of a project via the online tool should be self-explanatory.

## I. General Information for Applicants

### What is the EU-LAC Interest Group?

The EU-LAC Interest Group was founded in March 2017 in order to maintain the very active bi-regional network built by the EC-funded ERANet-LAC project (2013-2017). It consists of 29 funding agencies from both regions wishing to cooperate in bi-regional science, technology and innovation (STI). The activities organized by the EU-LAC Interest Group aim to support the implementation of the Common EU-LAC Research Area and to create further added value to its four pillars: Mobility of Researchers; increased thematic cooperation to address global challenges, international outreach of Research Infrastructures and Innovation. The European Commission is participating in this initiative with a specific view of maintaining the overall coherence with the Governance of the EU-LAC relations.

So far, EU-LAC funding agencies successfully organized three joint calls: Between 2013 and 2017 the 18 ERANet-LAC partners carried out two transnational joint calls and in 2017/2018 the EU-LAC Interest Group organized successfully its first joint call.

### Which are the fundamental principles of the 4th EU-LAC Joint Call in STI?

The EU-LAC Calls for Collaborative Research and / or Innovation projects are transnational research support instruments developed by and for the countries participating as funding institutions in the calls. They are implemented through a coordinated funding scheme whereby each Funding Party will fund its own national scientific teams within a multilateral project ("Virtual Common Pot", see as well page 7). Their budget is used for the competitive support of Collaborative Research and/or Innovation projects that will have an impact on enhancing the cooperation potential between Europe, Latin America and the Caribbean countries.

### Which countries are participating in the 4th EU-LAC Joint Call?

Austria, Bolivia, Brazil, Dominican Republic, Germany, Italy, Panama, Peru, Portugal, Poland, Spain, Turkey and Uruguay.

### Which institutions are providing funding for the call?

Not all EU and LAC countries are listed above. Does that mean that the countries that are not listed are not eligible for participation and funding?

Partners from countries that are not listed may also be part of consortia as long as they are able to clearly demonstrate an added value to the consortium and secure their own funding. However, the coordinator and the majority of partners in a consortium must be eligible to be funded by the funding organizations participating in this Joint Call. The self-financed/associated partners must provide the Call Secretariat with a signed official letter of support from their Head of Department or Financial Director. A pdf-version of this letter must be included as an annex at the end of the proposal when submitted.

What are the fundamental principles of the 4th Joint Call?

The fundamental principles of the call guiding the selection of projects to be funded are:

- Transparency. The process for reaching funding decisions will be clearly described and available to any interested party.
- Equality of treatment. All proposals shall be treated alike, irrespective of where they originate or the identity of the proposers.
- Ethical considerations. Any proposal that contravenes fundamental ethical principles may be excluded from being evaluated and selected at any time.

Which research topics are eligible for funding under the 4th Joint Call?

Research proposals can be submitted to the following thematic fields and topics:

#### 1. GLOBAL CHALLENGES

- 1.1. Global Challenges I - Interactions and integration between the climate science, SSH and other communities
- 1.2. Global Challenges II / Cross-cutting digital research infrastructure

2. HEALTH
  - 2.1. Health I - Personalised Medicine
  - 2.2. Health II - EU-LAC Regional Hubs: Integrating research infrastructures for Health and Disease
3. BIODIVERSITY
  - 3.1. Biodiversity and Ecosystem Services Research Infrastructures
4. ENERGY
  - 4.1. Interoperability of energy data spaces for an optimized exploitation by producers and prosumers / Research Infrastructures

Do I need to have an agreement with my national funding body in order to submit a proposal within the EU-LAC Joint Call?

No. Any eligible institution from a country participating in this call can submit a proposal directly to the Joint Call Secretariat using the PT Outline Management System.

The participating countries have appointed national Call Contact Persons (CCP) who will help research institutions from the respective countries to submit applications. If you need special support and assistance for your project preparation, please contact your CCP (a list of CCPs is provided in Annex 1 and also at the [EUCELAC Platform](#)).

Which Funding Scheme will be applied in the Joint Call?

The 4th EU-LAC Joint Call will be implemented through a *coordinated funding scheme* where each Funding Party will fund its own national scientific teams within a multilateral project ("*Virtual Common Pot*"), with a view to harmonize the funding contributions in order to guarantee the funding of the highest-quality projects with added value for bi-regional cooperation which have been selected through a peer review process.

The country contributions are listed in the Funding Contribution Table shown as Table 1 in this guide and in the Annex 2 of the Call Text.

How do I submit a project proposal under the EU-LAC Joint Call?

Project proposals are submitted through the web-based Call Management System PT Outline. In order to start the application procedure, please visit: <https://ptoutline.eu/app/eu-lac-2022> and follow the indications provided

Note that proposals submitted by post, e-mail, fax or any other means will not be accepted and rejected without further review.

In addition to the online submission procedure, should I submit a paper copy of the proposal?

No, you should not send a paper version of the project proposal to the Call Secretariat. Some funding organizations may, however, ask for a copy of the application for internal processes (see the National Regulations annexed to the Call Text for details). If funded, you may also be asked to provide further information to each funding agency.

Is there a deadline for the submission of a project proposal?

Yes. The deadline for the submission of a research proposal is **28 April 2022, 5PM CEST**. Note that access to the on-line submission system will be closed after the deadline.

What are the national eligibility criteria?

The 4th EU-LAC joint call includes different national funding organizations with their own call management system. In order to respect the necessary national funding rules and procedures, national eligibility criteria have been defined by the participating countries. Project partners are advised to check in advance what type of costs are eligible for national beneficiaries as well as the

funding rates and limits of the countries in question. See details in the internal/ national Eligibility and Funding Rules <https://www.eucelac-platform.eu/> and/or contact your national Call Contact Person (Annex 1).

### Which types of institutions are eligible for participation and funding?

Applicants can represent public and private scientific, research, technological and innovation institutions on national, federal or EU-LAC regional level, research active industry and NGOs and other institutions involved in research and or innovation activities, as long as they are eligible for funding according to the respective national and/or institutional regulations. To check if your institution is eligible for funding, see the specific internal/ national funding regulations (see <https://www.eucelac-platform.eu/joint-actions>) and/or contact your national Call Contact Person (Annex 1 and EUCELAC platform).

### How can I find the appropriate partner institutions?

The EU-LAC Interest Group together with the EU funded ENRICH-LAC Project, supports the identification of partner institutions in Latina-America/Caribbean and Europe. On the website <https://europe-lac.b2match.io/> a partner search tool is published to help bring together interested applicants from countries in both regions.

All requests will be published in the search tool and made available to all interested institutions immediately.

### Can I be an evaluator and a partner of a project proposal at the same time?

No! If you are the coordinator or a partner in a project proposal of the 4<sup>th</sup> EU-LAC Joint Call, you are not allowed to perform as evaluator.

Evaluators are selected by the Group of Funding Parties from a database following a pre-selection procedure through the Call Secretariat.

### What is the role of the coordinator?

The project coordinator has the overall responsibility for the project, and will represent the consortium in all communication with the Call Secretariat. The coordinator is responsible for submitting the proposal, and will receive the results of the evaluation. The contact data for the Coordinator her/himself (and optionally for her/his support staff) as well as for the institution must be given in the proposal.

It is recommended that the coordinators counter check the eligibility of all partners with the CCPs. (see list of CCPs in Annex 1). Coordinators are allowed to contact the partners' national CCPs.

### What is the role of the principal investigator?



There should be a principal investigator (PI) for each of the national research groups. Within a joint proposal, the principal investigator from each country will be the contact person for the respective national funding organizations.

One of these PIs should be selected through the project consortium as coordinator to represent the consortium, submit the proposal and establish any further communication with the Call Secretariat. The principal investigators within a joint proposal (Latin-American/Caribbean and European) will be the contact persons for the respective national funding organizations.

#### Must all partners be included in the project proposal at the submission stage?

Yes. The whole consortium must be identified and included from the start of the project. It is important to ensure that the minimum participation requirements are met (see next question below) and that all consortium partners are eligible for funding according to the national eligibility and funding rules.

#### How many partners must cooperate in a project proposal?

Each consortium submitting a proposal must involve a minimum of four eligible partners from four different countries with at least two countries from each region (see the list of funding organizations above).

There might be defined a maximum number of national partners applying for funding in the institutional rules of each funding organisation. The coordinator and the majority of partners in a consortium must be eligible for the funding organizations participating in this Call, complying with the minimum number of eligible partners as indicated above

Self-financed associated partners may also be part of the consortia if they can clearly demonstrate an added value to the consortium and secure their own funding.

The associated partners must provide the Call Secretariat with a signed official letter of support from their Head of Department, Financial Director, or equivalent position, stating the commitment of the organization/company to provide its own funding. This letter must be included as an annex at the end of the proposal submission form.

Only transnational projects will be funded. Each collaborative consortium should have the optimal critical mass to achieve ambitious scientific/innovation goals and should clearly show an added value from working together.

#### Can I submit more than one proposal as a coordinator?

No. However, one research institution – as a legal entity – is allowed to participate as a coordinator or partner in several project proposals.

#### May I submit a proposal twice?

A given proposal may only be submitted for one of the topics supported within the framework of the 4th EU-LAC joint call; otherwise it will be considered non-eligible.

Researchers are only allowed to participate in one proposal as principal investigator of the

coordinating institution. Internal/ national funding regulations might add additional eligibility criteria with regards to participation in several proposals. .

What happens if one of the project partners is found ineligible for funding after the submission of a project proposal?

If the Project Coordinator does not meet the international or national eligibility requirements, the proposal will not be admitted to the evaluation procedure.

In case (a) Co-applicant(s) is (are) ineligible, the proposal may still be eligible if and when the eligibility criteria are met by the proposal without this (these) partner(s).

Should I provide a detailed financial plan when submitting a project proposal?

Yes. The project coordinator is expected to calculate the overall costs and the requested amounts per partner. In the project description template form it is required to give a detailed description of the requested funds for each cost category (Personal costs, travel, other direct/indirect cost and costs related to research infrastructures use: equipment, connection costs, software, consumables, secondments, data access and other costs).

How many applicants from a country are allowed to participate in a project?

Each funding organization decides about a maximum number of national partners applying for funding. Please ask your CCP (Annex 1) in case this is not defined in the national rules of your country.

What are the requirements for a Consortium Agreement?

Each consortium selected for funding must provide a Consortium Agreement (CA), signed by all participants, to clarify the potential Intellectual Property Rights (IPR) matters (such as licensing in, licensing out, patent and exploitation strategy). The consortium agreement must be sent to the call secretariat before the project starts officially. It must address (as a minimum), the following points:

- Common start date and duration of the research and / or innovation project
- Organization and management of the project
- Role and responsibilities of each partner resources and funding
- Confidentiality and publishing
- Intellectual Property Rights
- Decision making within the consortium
- Handling of internal disputes
- The liabilities of the research partners towards one another (including the handling of default of contract)

Any issues regarding funding are a bilateral matter between each project partner and the relevant funding organization and should be excluded from the CA. The CA, together with any other information required by national regulations, must be made available upon request to the national funding agencies.

What are the evaluation criteria for a project proposal?

The evaluation procedure will be done according to the criteria defined in the following:

1. Excellence

- Clarity and pertinence of the objectives;
- Credibility of the proposed approach;
- Integration of diversity considerations in submitted proposals, as well as underrepresented populations in the planned research/innovation. This includes not only diversity in the consortium, but also the inclusion of diversity perspectives and analysis in the research/innovation itself if it is relevant. A project is considered diversity (or gender) relevant when it concerns individuals or specific groups of people and/or when its findings may affect individuals or specific groups.
- Soundness of the concept, including trans-disciplinary considerations, where relevant;
- Extent to which the proposed work is ambitious, has innovation potential, and is beyond the state of the art (e.g. ground-breaking objectives, novel concepts and approaches).

2. Impact

- Expected impacts listed in the description under the relevant topic;
- Enhancing research and innovation capacity and integration of new knowledge;
- Any other environmental and socially important impacts;
- Implementation of Open Science measures (early and open sharing of research; research output management; providing open access to research outputs i.e. publications, data, software, algorithms, etc.), participation in open peer review; involvement of relevant actors including citizens, civil society and end users in the co-creation of R&I contents and agendas;
- Effectiveness of the proposed measures to exploit and disseminate the project results (including management of IPR), to communicate the project and to manage research data where relevant;
- Added value for the EU-LAC cooperation in STI;
- Mobility, networking and training of human resources in both regions;
- For Research Infrastructures topics: Contribution of the RI use to the impact of the project.

3. Quality and efficiency of the implementation

- Coherence and effectiveness of the work plan, including appropriateness of the allocation of tasks and resources;
- Complementarity of the participants within the consortium (if relevant) and gender balance among them;
- Appropriateness of the management structures and procedures, including risk and innovation management;
- For Research Infrastructures topics: Appropriateness of the proposal to the research

infrastructure.

4. Economic impact, applicability and exploitation of results
  - Potential for economic impact and exploitation/transfer of results;
  - In case of industry and SME participation: Strengthening competitiveness and growth of companies by developing innovations that meet the needs of global markets and, where relevant, deliver such innovations to the market;
  - Feasibility;
  - Involvement of stakeholders;
  - Communication and dissemination of results;
  - Exploitation and transfer of results;
  - Management of intellectual property issues and consortium agreements.

#### What are the rating scores for a project proposal?

The evaluators are requested to assess proposals against a set of criteria, each of which may be awarded a maximum of 5 points per criterion, 20 points maximum, according to the following scale:

EXCELLENT = 5 points The proposal successfully addresses all relevant aspects of the criterion. Any shortcomings are minor.
VERY GOOD = 4 points The proposal addresses the criterion very well, but a small number of shortcomings are present.
GOOD = 3 points The proposal addresses the criterion well, but a number of shortcomings are present.
FAIR = 2 points The proposal broadly addresses the criterion, but there are significant weaknesses.
POOR = 1 point The criterion is inadequately addressed, or there are serious inherent weaknesses.
0 points The proposal fails to address the criterion or cannot be assessed due to missing or incomplete information.

No additional criteria will be used for evaluation and selection of the proposals.

#### What is the evaluation procedure for the EU-LAC Joint Call?

The selection of the proposals for funding is based on an international, independent remote peer-review procedure. A dedicated pool of evaluators, consisting of external independent experts, will assess anonymously the merits of the submitted proposals. Each proposal will be evaluated by two external independent evaluators. Following the peer-review process, Scientific Expert Committees, consisting of scientifically multidisciplinary experts with large experience in managing, following and evaluating transnational projects in each of the thematic areas, will consolidate the results of the evaluation and make recommendations to the Group of Funding Parties (GFP).

The final recommendation for funding rests with the Group of Funding Parties. The formal funding decision will be made by the respective national Funding Party.







Step 2: on the page General Information you must include the basic information on the project: keywords, project acronym, project title, project summary, expected start date, duration, thematic area/topics and participating research infrastructures from LAC or EU (if applicable).


